CONFIRMATORY DEED

The City of Malden, a municipal corporation with business offices located at 110 Pleasant Street, Malden, Middlesex County, Massachusetts, by and through its Mayor, pursuant to and in accordance with the Orders of the Malden City Council in Paper #353 of 2015, enacted June 26, 2015, hereby conveys to the City of Malden the following described land in Malden, to be permanently protected, preserved and provided in perpetuity for public enjoyment and use as open space, passive recreation and conservation land:

The land owned by the City of Malden, off Williams Street, High Rock Road, Rockingham Avenue and Nanepashemet Avenue, in Malden, containing approximately 301,964 square feet (6.93 acres) in total, as shown on a plan of land entitled "High Rock Road in Malden, MA", dated February 1, 2017, prepared by Stephen M. Melesciuc, P. L. S., of Marchionda & Associates, L. P., consolidating five parcels of land owned by the City of Malden, which plan is recorded herewith.

Gately and Roderick C. MacDonald III to Kevin Douglas and Steve Langton, Trustees, recorded in Middlesex South District Registry of Deeds Book 57549, Page 31, and an Agreement entered by Edward R. Salie and Susan — Salie and the City of Malden, dated February 28, 2017, and recorded with Waddlesex South District Registry of Deeds in Book 68948, Page 258.

Meaning and intending to convey said land perpentially for public use, to permanently restrict and limit use of said land to the public for a prevation purposes, and to retain said land in its natural, scenic and open condition for public recreational use and enjoyment in accordance with the Orders of the Malden City Council in Paper #353 of 2015 enacted June 26, 2015.
